To get started you'll need to complete a simple Gift Aid declaration form, which can be found on our website:

If you are a UK taxpayer, Gift Aid is a simple way to increase the value of your donations. We can claim 25p from the Government for every £1 donated, at no extra cost to you or your sponsor.

Important things to consider - ticking all the boxes Raffles, Lotteries & Prize Draws 'in aid of' Canine Partners Raffles, lotteries and prize draws are a great way to boost your

fundraising - everyone loves the opportunity to win something! Small raffles (called an 'incidental lottery') that are part of a bigger event don't need a licence as long as there's no cash prize and you're not spending more than £500 on prizes.

You're only permitted to sell tickets at one location, on one day, at the same event as the draw and the results of the draw are announced at the event or afterwards. If you plan to raise funds

in this way please let us know and we can provide further information on how to explain that your event raffle is raising

If you are running a raffle, lottery or prize draw in any other way please make sure you follow the rules to ensure you are fundraising within the law. Check the latest guidance from
